The most widespread human rights violation globally

killings of women, abuses against women and girls female genital mutilation Less than 40% ask for help

- Important for orgs: implicit trust on grantees to be able to work in that system,
- innovations: TF helped
- TF brought multiyear grants change structures and cultures
- Standardization of procedures and toolkits
- Joint action from other grant givers

- Recent UNTF grantee
- huge role of small organizations
- improve their technical capacity
- to write proposals
- to build connections I
- earn from larger organizations
- to acquire best practices on how to run programmes.

#### Reem Alsalem Women rights organization, UN Special Rapporteur on violence against women

- Comprehensive approach: legal, data acquisition and interpretation, prevention
- Important role of communities, private actors and NGOs
- 2030 agenda: the issue of ending violence against women ( Gender Based Violence) is inserted in the gender equality issue, in women's empowerment
- Strengths: support civil society organizations
- Daring and innovative projects
- Long term grants

- SASA INITIATIVE: Start, Awareness, Support, Action
- Prevention of GBV, community mobilization
- funded twice by the UNTF
- related to prevention of HIV.
- adapted to various countries, South America
- a practice -based knowledge
- reduce the social acceptability of GBV
- impact HIV risk
- Important involvement of men and boys
- GBV is preventable
- HIV can be curbed with action against GBV



#### Ms Jaya Luintel: co-founder The Story Kitchen, Nepal

- 10 years old civil war in Nepal
- TSK agency for survivals of violence
- Telling stories of violence helps unravel gender oppression and patriarchy
- silenced by family, society and the government
- turns victims into reporters
- power of words and stories
- Iong-term partnership with the UNTF and the EU
- from 5 districts to 18 districts in Nepal
- trust, passion integrity, recognition, amplification



#### Ms Katherine Flayley, Women's Justice Initiative, Guatemala

- NGO received 2 rounds of funding from UNTF
- funding duration impacts on the projects
- more creative projects radio programs to involve boys and men
- advocacy
- Results take time to be achieved
